












- Open to both STBC members and nonmembers

  - Emails coming soon












#### **Ride of Silence – John Norris**

#### **Ride Schedule – David Wells**

- Weekend Rides: Despite very few advance-scheduled rides being in calendar in early part of year, weekend rides were active. Out of 26 weekends, Apr 1 – Oct 31, 20 ride offerings were available. This includes some weekend days where there were two offerings and doesn't include some weekend rides which were announced 2 days or less in advance. Participation seemed generally on par with weekend rides of pre-pandemic years.
- Weekday Rides: Except for weather cancellations, PBJ and W2M rides occurred with great regularity, and were well-attended.
- Weeknight Rides: Monday night ice cream rides and Thursday night Cranks & Comestibles occurred with good regularity and were well attended, as allowed by weather.
- Special Event Rides: Ride of Silence, Binghamton Bridge Pedal, Highway Cleanups, Memorial Rides all occurred and with generally good attendance.


