

CERTIFICATE OF INCORPORATION

of

SOUTHERN TIER BICYCLE CLUB, Inc.
Under Section 402 of the Not-for-Profit
Corporation Law

1. The name of the proposed corporation shall be:
" SOUTHERN TIER BICYCLE CLUB, INC."
 2. The corporation is not organized for pecuniary profit or financial gain, and no part of its net earnings shall inure to the benefit of any member, director or individual.
 3. The purposes for which it is to be formed are:
 - (a) To promote general interest in cycling activities, in particular to promote bicycle commuting, touring, and racing.
 - (b) To encourage public authorities to allocate facilities on public lands for the use of cyclists, in particular bikeways, and to secure bicycle parking.
 - (c) To improve the public's awareness of the cyclist's purpose, rights, and vulnerabilities.
 - (d) To provide social and athletic recreation for its members.
 4. The proposed corporation shall be a Type A Corporation under Section 201 of the Not-for-Profit Corporation Law.
 5. The office of the corporation shall be located in the City of Binghamton, County of Broome and State of New York.
 6. The territory in which its operations are principally to be conducted is within the boundaries of counties of Tioga, Broome and Chenango of the State of New York.
